## Meeting minutes

A meeting of the **State Quality Assurance Committee** was held under the chairmanship of Additional Chief Secretary, Medical, Health & FW Department on 8.08.2018 at 4:30 pm in room no 305, IInd floor, NHM Building, Swasthay Bhawan Jaipur . Following decisions were taken in the meeting:

- 1. Dr. Rambabu Jaiswal, SNO QA welcomed everyone and gave a brief on the action taken report of the previous meeting and progress of the Quality assurance programme made in the year 2018-19.
- 2. Committee was updated that as per the new amendment made in BMW rules in 2018, extension upto March 27, 2019 has been given for establishing the barcode system. It was decided that the HA deptt. will coordinate with Pollution Control Board for implementation of same. (Responsibility: Addl. Dir. HA).
- 3. It was discussed in the meeting that for manpower related gaps of the facilities nominated for national assessment SNO QA & Kayakalp will have a separate meeting with Director PH and Addl. Dir Gaz & Non Gaztt. for finding the solution to same. (Responsibility: SNO QA & Kayakalp)
- 4. It was decided in the meeting for ensuring that the medical colleges run and reports the microbiological sample received from the public health facilities, same should be perused from medical health and education dept so that instructions can be issued from their end. (Responsibility: State Quality Cell).
  - For districts conducting the DQAC meeting with DHS meeting, it was decided that instructions will be issued to DPM to ensure that a separate agenda for discussing the progress and gaps of the Quality Assurance programme is included in every DHS meeting and Minutes of Meeting are forwarded to the cell quarterly. - 6. Consultant FRU, gave a brief presentation on the progress of the Laqshya programme in the state. It was decided that the facilities scoring more than 70 % should be state certified and process for state certification should be initiated through MH wing as per GOI guidelines.
